#### **INVITATION FOR "EXPRESSION OF INTEREST"**

"Expression of Interest for supply of Dehulled millets Rice to Nutrihub-TBISC, ICAR-IIMR Campus, Rajendranagar, Hyderabad 500030"

Nutrihub-TBISC proposes to invite "Expression of Interest for supply of below mentioned Dehulled millet rice quantities from millet-based FPO's (Farmer Producer Organizations) and registered traders and MSME's"

Scope of supply requesting all FPO's and registered traders and MSME's to read all terms and conditions and please fill as given separate columns in the above table (Willing to Supply -Yes /No). You may submit duly filled in Expression of Interest" with all the necessary required information on or before 16.00 Hrs dated: 09-06-2023 by register post or courier to Dr. B. Dayakar Rao, CEO/Director, Nutrihub-TBISC, ICAR-IIMR Campus, Rajendranagar, Hyderabad -500030.

#### **Terms and Conditions:**

- 01. The interested parties (FPOs, registered traders and MSMEs) should enclose the copy of **self-attested registered** certificate issued by Central/State/Registered Society. Complete profile of firm with address and contact details may be submitted on Company's letter head.
- 02. In case of Sole proprietor, they should enclose the copy of self attested any **documentary** evidence indicating proof of business and identity card issued by any Govt. Department.
- 03. All the interested parties are requested to submit the compliance as per Annexure-I duly stamped along with the sample of each Dehulled Millet Rice in 5 kg packaging to Dr. B. Dayakar Rao, CEO/Director, Nutrihub-TBISC on or before 09.06.2023, 4:00 PM.
- 04. All bidders/ Traders should possess experience in supply of Dehulled Millets Rice to any

- 05. firm/Govt. Organization/retail selling through their outlets. Self-attested relevant proof should be submitted.
- 06. Nutrihub-TBISC reserves the right to accept or reject all or any such "Expression of Interest" application without assigning any reason. CEO/Director, Nutrihub-TBISC decision shall be final and binding in all respects.
- 07. Nutrihub-TBISC will procure the Dehulled Millets Rice as and when required depending upon necessity and available budget.
- 08. Identified Traders/bidders will be enrolled as 'registered suppliers'. This will be hosted on our website. For enrolment purpose, a non- refundable registration fee of Rs.1000/- may be submitted in favour of CEO, Nutrihub-TBISC, Rajendranagar, Hyderabad in form of Demand draft.
- 09. Price quotation will be sought from the "registered suppliers" only for the relevant Dehulled Millets Rice and the lowest will be chosen for supply of the same. In case, some firms end up with same price among the registered suppliers; quantity of items will be redistributed equally. The decision of CEO, Nutrihub-TBISC in this regard shall be binding and final.
- 10. The rate quoted should be reasonable, lowest and fixed for that supply. Price quoted should be inclusive of all taxes and transportation to Nutrihub-TBISC, Rajendranagar storage place in Hyderabad. Change in price quoted, whatsoever may be the reason, after submitting their quotation shall not be accepted. In case, the lowest bidder/registered supplier fails to supply, the supplier will be black listed and debarred for a period of three years.
- 10. In case the registered supplier is not in a condition to supply all the ordered material at a time, the same should be informed immediately seeking exact time of supply. Nutrihub-TBISC may accept part supply or reject.
- 11. Addendum/Amendment, if any, to this EOI, will be hosted at our website (www.nutrihubiimr.com) before two days of the due date. Hence FP0's, registered traders and MSME's are requested to verify the website periodically for announcements.
- 12. Nutrihub-TBISC shall not pay any advance to any supplier.
- 13. The quantity sought is tentative, and may increase/decrease upto 40% depending upon necessity and budget.

- 14. Payment will be done after receipt of material in full and duly certified by the indenter.
- 15. In case of delay in supplying the material, liquidated damages will be levied @ 0.5% per week subjected to maximum of 10% of the order value and suitable legal action will be taken against the firm. In case of arbitration, jurisdiction will be Hyderabad Court.
- 16. Material should be supplied in neat packing and in good condition.
- 17. Supply of material should be clean and sorted with color sortex. Wastage more than 1% is not allowed (including brokens & un-hulled).
